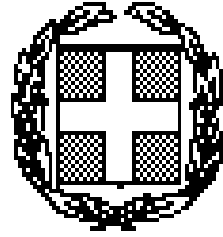

- ✓ The establishment of suitable circumstances in all three Prefectures of the Region for the promotion of employment at the local level
- ✓ Information and sensitization on the policies discussed at the European level with respect to employment issues
- ✓ Collaboration with the Public Sector employees for the implementation of the employment strategy
- ✓ Registration of the current status of the labour market in the Region
- ✓ Development of "tools" that will support the entire effort

RESULTS

- ✓ Analysis of the Region's social and economic data

- ✓ The creation of a dossier containing the proposed employment strategy at the regional level, structured in Actions and Measures that are possible to be integrated to the Regional Operational Program of Western Greece
- ✓ Submission of the dossier containing the proposed strategy to the Ministry of Labour and Social Security as well as to other competent authorities
- ✓ Presentation of the general implementation methodology
- ✓ Establishment of human networks by local and regional bodies for the support of the employment strategy at the local level
